The World Bank, for example, deems a country to be "fragile" if it (a) is eligible for assistance (i.e., a grant) from the International Development Association (IDA) (b) has had a UN peacekeeping mission in the last three years, and (c) States of Fragility Reports - OECD States of Fragility 2018 exposes the critical challenge posed by fragility in achieving the aspirations of the 2030 Agenda, sustainable development and peace.
